Regulations for exhibiting in 2023 ISEE & CEFE powered by INTERSCHUTZ

Exhibitors must accept all the following rules and regulations for participating in the 2023 ISEE & CEFE powered by INTERSCHUTZ. They are also obligated to ensure that all work is in accordance with applicable regulations and legal policies, as well as the technical regulations of Nanjing International Expo Center, which together with the stand application form constitute the exhibition contract.

A contract concluded

When applying for the booth, the exhibitor must fill in and submit the complete application form, which has the legal effect. The organizer has the right to handle the registration of exhibitors only after receiving all the advance payment. The full payment is a prerequisite for the use of the allocated booth/inclusion in the show catalog and entrance pass. If the exhibitor fails to fulfill the payment obligation, the organizer has the right to terminate the exhibition contract.

The booth allocation

The organizer is responsible for the allocation of booths and has the right to make the final decision and interpret the changes of booths in the exhibition hall. The exhibitor has no right to allocate any booth and any booth space on the exhibition.

In case of special circumstances, the organizer has the right to safeguard the overall interests of the exhibition by redistributing the booths, changing the space of the booths, moving or closing the entrance and exit of the exhibition hall, and making other necessary changes. The exhibitor has the right to give a written notice to cancel the booth within one week after receiving the notice of change if this is harmful to the exhibitor's interests. The exhibitor has no right to claim compensation for any expenses caused by this, but the advance payment and the paid stand fee will be refunded.

Booth building and booth design

Exhibitors are also obliged to ensure that all work is done in accordance with applicable regulations and statutory policies, as well as the technical regulations of Nanjing International Expo Center, which together constitute the terms of participation.

Exhibitors who rely on each other at the back of the booth should communicate and negotiate with each other during the design and construction of the booth, so as not to allow the structure to cross the boundary.

In the event of a public display at the booth, the exhibitor must take steps to ensure that there is no visual or acoustic impact on the surrounding booths. In addition, public areas around booths should not be blocked. The sound of the booth should not exceed 70 decibels at the booth boundary. If any exhibitor violates the rules, the organizer has the right to take steps. In case of repeated violation of regulations, which causes dissatisfaction and obstruction, the organizer has the right to terminate the contract with immediate effect, and the paid stand fee is non-refundable.

Exhibitors shall take full responsibility and enjoy full rights and interests for all their exhibition activities, including but not limited to the display of exhibits, publicity activities, behavior and personal safety of staff or employees, raw space construction, disassembly and cleaning and construction activities of the entrusted or contracted construction parties, etc.

The exhibits on display

During the opening hours of the exhibition, there must be staff present and display the exhibits. Products outside the exhibition scope are not allowed to be displayed. The organizer has the right to remove the exhibits that violate the principles of competition law and relevant laws and regulations or are prohibited by other venues.

Retail or cash sales to individuals or business persons on site are prohibited, especially the sale of exhibited goods or samples. Retail or cash sales refer to the transfer of goods for payment or the provision of paid services by the exhibitor in the exhibition hall. Exhibitors have the right to give their exhibits free of charge or sign other contracts. Exhibitors can only conduct research and promotional activities at their own booth.

To protect the interests of the exhibitors, it is suggested that the exhibitors should insure their exhibits against theft, and the exhibitors should be fully responsible for any loss or damage to any property of the exhibition venue, other

exhibitors or organizations due to the action or omission of their employees or agents.

Installation and disassemble

The organizing unit has the right to dispose of any items which should not be removed within the withdrawal date, and the exhibitor shall pay the relevant expenses. The organizer is under no obligation to store such items, and items that have not been removed in time will be considered abandoned.

Reservation clause

The organizer has the right to postpone, reduce or cancel the whole or part of the exhibition according to the actual situation (such as the epidemic or other force majeure, the insufficient number of exhibitors). If the exhibition is canceled in whole, the paid stand fee will be refunded. If the exhibition is delayed or reduced in part, the contract will apply to the new extension period and the organizer will formally notify the exhibitor in writing, unless the exhibitor objects in writing within two weeks of the organizer's adjustment. No discount will be given to the determined fees and no compensation will be given to the exhibitor for the expenses incurred as a result of their trust in the operation of the exhibition.

Exclusive responsibility

Exhibitors have a duty to look after their own exhibits, booth equipment and other objects, organizer of exhibits and booth device and other items of damage to or loss of irresponsible, also does not assume employees and their representative caused by damage to or loss of any responsibility, but as a result of malicious or gross negligence cases, except for the damage caused. These exclusivity liabilities also apply when booth installations or exhibits are held by the organizer under a lien. These exclusivity responsibilities will not be diminished by security measures. Of the organizer to the whole exhibition, because at the booth area allocation, booth structures, or approval of the booth design, show catalogue entry error messages, and due to the booth area of adjustment and other bad service, and the absence of timely written objection, exempt from any demand to reduce the rent, It also exonerates the exhibitor from all liability for any losses suffered as a result of this - except in the case of malicious sabotage or gross negligence by its employees or other representatives.

Early termination of the lease contract

After the exhibitor has applied for the exhibition and paid the advance payment, the advance payment will not be refunded if the application for the exhibition is cancelled before all the stand fees have been paid.

If the exhibitor requests to cancel the contract and withdraw from the exhibition after fully taking effect and paying all the stand fees, it will be handled separately according to the time of cancellation. If the contract is cancelled more than 3 months before the opening of the exhibition, the exhibitor shall pay the liquidated damages of 60% of the exhibition fees. If the contract is cancelled within 3 months from the launch, the penalty will be 100% of the exhibition fee. The organizer has the right to offset the advance payment and stand fees of the exhibitors against the liquidated damages payable.

Intellectual property protection

Exhibitors shall have their own intellectual property rights or have been authorized by the intellectual property owner, and shall not infringe on the products they exhibit. If the exhibits are indeed infringing, the exhibitor shall withdraw the exhibits and cooperate with the organizing unit and relevant legal institutions for investigation. The exhibitor has no right to ask for refund of the booth fee on the grounds that the exhibits are withdrawn.

Applicable law, place of adjudication

This contract is signed with the exhibitor and is governed by the laws of the People's Republic of China.

The arbitration place for disputes concerning the participation matters shall be Jianye Nanjing, China, where the Nanjing International Expo Center is located.

DATA PROTECTION CLAUSE

The Exhibitor agrees and hereby authorizes the Sponsor or the Organizer to use all kinds of company data and personal information of related personnel submitted to the Sponsor or the Organizer in connection with registration, enrollment, contract signing and follow-up services for matters related to the Exhibition, including but not limited to:

- To provide company data and personal information of relevant personnel to Service Providers (including but not limited to booth constructors, marketing service providers of the exhibition, logistic service builders, who engaged or commissioned by the Sponsor or the Organizer for the Service Providers to contact the Exhibitor and its designated contact or personnel in charge of the exhibition preparation, booth construction, transportation of exhibited products, etc.
- To provide company data and personal information of relevant personnel to the Sponsor or Organizer's co-organizers for the co-organizers to provide exhibition service;
- To provide company data and personal information of related personnel to the Sponsor or third parties chosen by the Organizer for the purpose of providing other services related to the exhibition, delivery of exhibition information, or provide promotional service for exhibition and the Exhibitor.

The Exhibitor agrees that it assumes full liability concerning the data or personal information it provides to the Sponsor or the Organizer (except for the losses caused due to the Sponsor or the Organizer's failure comply with their legal or agreed data security obligations). The Exhibitor shall be solely responsible for independently determining whether it has full legal rights and authorization to use and provide such data or personal information. The Exhibitor undertakes and warrants that all personal information it provides to the Sponsor, the Organizer or their designated third parties has been provided with the voluntary and express informed consent of the relevant subject of personal information, i.e., the Exhibitor expressly informs the subject of personal information that the Exhibitor will provide the personal information to the Sponsor, the Organizer or their designated third parties for the provision of services by the Sponsor, the Organizer or their designated third parties, and the subject of personal information expressly consents thereto.
